On the basis of Article 55, Paragraph 8 of the Higher Education Act (Official Gazette of the Republic of Slovenia, No. 32/12-UPB7 and its amendments) and Article 38 of the Statute of the University of Primorska (Official Gazette of the Republic of Slovenia, No. 51/15-UPB2 and its amendments), at its 36th regular session on 12 December 2018, the Senate of the University of Primorska adopted the following

**GUIDELINES FOR AMENDMENTS AND ADDENDA
TO THE GUIDELINES FOR THE IMPLEMENTATION OF THE CRITERIA FOR APPOINTMENT TO
TEACHING, RESEARCH AND ASSOCIATE POSITIONS AT THE UNIVERSITY OF PRIMORSKA**

Article 1

In Appendix "1. Samples of applications for appointments to positions – for each individual position (SAMPLE 1)" of the Guidelines for the Implementation of the Criteria for Appointment to Teaching, Research and Associate Positions at the University of Primorska (NPB2, No. 002-10/18 of 28 February 2018 and its amendment No. 002-17/18 of 11 July 2018, hereinafter: Guidelines), the samples of applications for appointments to positions shall be completed with the following samples of applications for appointments to Research and Development Positions:

- Developer – first appointment,
- Developer – reappointment,
- Senior Developer – first appointment,
- Senior Developer – reappointment,
- Independent developer – first appointment,
- Independent Developer – reappointment,
- Development Associate – first appointment,
- Development Associate – reappointment,
- Senior Development Associate – first appointment,
- Senior Development Associate – reappointment,
- Development Counsellor.

Article 2

Samples of applications for appointments to positions from Article 1 are the appendices to these Guidelines.
